## Executive Summary

## Background

SSM Health St. Mary's Hospital - Audrain is pleased to present the 2016-2018 (2016 Tax Year) Community Health Needs Assessment (CHNA). This CHNA report provides an overview of the health needs and priorities associated with our service area. The goal of this report is to provide individuals with a deeper understanding of the health needs in their community, as well as help guide the hospital in its community benefit planning efforts and development of an implementation strategy to address evaluated needs. The SSM Health Mid-Mo Regional Board approved this CHNA on Dec. 17, 2015. SSM Health St. Mary's Hospital - Audrain last conducted a CHNA in 2012.

The Affordable Care Act (ACA) requires 501(c)(3), tax-exempt hospitals to conduct a CHNA every three tax years and adopt a strategic implementation plan for addressing identified needs.

## Priorities

SSM Health St. Mary's Hospital - Audrain held a meeting with local, regional, and system members to determine priorities for the 2016-2018 CHNA and strategic implementation plan. Priorities chosen were:

- Heart Disease: Resources include but are not limited to the Jordan-Waters Heart Center and Healthworks Rehabilitation Services and SSM Health Medical Group.
- Cancer Care: Resources include but are not limited to SSM Health St. Mary's Cancer Center, Epic health notifications, the American Cancer Society and SSM Health Medical Group.


## Goals

## Heart Disease

- Reduce age-adjusted death rate due to heart disease in our region from 231.4 deaths per 100,000 individuals, as reported in 2015, to 225 deaths per 100,000 individuals by 2018 (MICA)
- Decrease percentage of all-cause/all-location congestive heart failure (CHF) 30-day hospital readmission rate at SSM Health St. Mary's Hospital - Audrain from 16\% in 2015 to 15.3\% by 2018 (HIDI)


## Cancer

- Reduce the age-adjusted death rate due to cancer in our region from 178.2 deaths per 100,000 individuals, as reported in 2015, to 175 deaths per 100,000 individuals by 2018 (MICA)
- Increase percentage of stage 1 breast cancer initial diagnosis' from 19.7\% (hospital 5-year 2010-2014 baseline average) to $24.7 \%$ by 2018 (Cancer Registrar)
- Increase percentage of stage 1 lung cancer initial diagnosis' from 37.5\% (hospital 5-year 2010-2014 baseline average) to 42.5\% in 2018 (Cancer Registrar)

## About the data

The data was derived from a variety of sources including the Healthy Communities Institute ( HCl ) analytics platform. The website includes the most up-to-date publicly available data for approximately 140 community indicators from over 20 sources and covering 20 topics in the areas of population health, determinants of health, and quality of life. Below is a statistical overview of strengths and weaknesses within the community that factored into our discussions with local stakeholders regarding the priority health needs of the population within our service area.

## Our community by the numbers



## Cancer

Cancer incidence rates are generally higher than both state and national averages. Areas of concern include breast, lung, prostate, colon and bladder cancers


## Heart Disease

Ischemic (advanced) heart disease prevalence, along with hypertension, hyperlipidemia and high blood pressure, are all generally higher than both state and national averages

## Access to Primary Care <br> Primary care access within Audrain County is better than the state average. However, access in Montgomery County is severely limited



## Mothers Who Smoked During Pregnancy

Mothers in both counties who reported smoking while pregnant is notably higher than the national average


## Low Birth Weights

Babies with very low birthweight is significantly above both state and national averages for Audrain and Montgomery Counties

## Obesity

The percentage of adults who are obese in Audrain and Montgomery Counties is higher than both state and nation averages


## Dental Care

Access to dental care in Audrain and Montgomery Counties, defined as the number of dentists available per 100,000 individuals, is below the state average

## Diabetes

The prevalence of diabetes in adult populations of both counties is generally above average. Specifically, the Medicare population of Montgomery County was significantly above average

## Teen Birth Rates

The teen birth rate in Montgomery County is double both state and national averages. However, the rate for Audrain County is notably below average


## Violent Crime

The general crime rate of the service area is significantly better than both state and national averages

## The Health Needs of Our Community

## Voice of the community

SSM Health St. Mary's Hospital - Audrain conducted a comprehensive community health assessment, which included soliciting feedback from the community in the form of surveys and focus groups.

Surveys were administered to SSM Health clinics in Auxvasse, Mexico, Montgomery City, Paris, Perry, Vandalia and Wellsville. Additional surveys were made available in the Montgomery County Health Department. Medical staff and patients responded over a one-month period, resulting in completed surveys from 24 providers and 96 patients. Focus groups gathered community feedback from 16 individuals, including representatives from both Audrain and Montgomery County Health Departments.

SSM Health St. Mary's Hospital - Audrain administration reviewed community perception results and health data, prioritizing the top two needs based on the extent of the deficiency and the ability of the hospital to make an impact.

## Key priorities

## Heart Disease



Heart disease the leading cause of death in both Audrain and Montgomery Counties. There are a number of deficiencies within our community that lead to poor heart health and are exacerbated by numerous risk factors including high blood pressure, high cholesterol, diabetes, obesity, poor nutrition and smoking.

The negative effects of these risk factors can be

## Cancer

Cancer is second only to heart disease as a leading cause of death in Audrain and Montgomery Counties. The top five most common types of cancers in our region are breast, lung, prostate, colon and bladder.

Proactive screening for cancer provides a significant opportunity to reduce mortality and increase survival rates.

## Heart Disease

Heart disease is the leading cause of death in both Audrain and Montgomery Counties. There are a number of deficiencies within our community that correlate to poor heart health. Some of these lifestyle behaviors that increase the risk of heart disease include:

- Smoking
- Uncontrolled blood pressure
- High cholesterol levels
- Uncontrolled diabetes
- Stress and depression
- Unhealthy food choices
- Lack of exercise

In some cases, minorities and those living under financial distress are often segments of the population who are most affected by factors contributing to heart disease.

SSM Health and SSM Health St. Mary's Hospital - Audrain offer a wide scope of programs with the goal of creating healthy lifestyle behaviors and reducing the risk of heart disease in our communities.


- The percentage of the Medicare population with hyperlipidemia in Audrain and Montgomery Counties is $47.1 \%$ and $44.4 \%$, respectively, both of which are higher than the state rate of 42.5\%
- The percentage of adults with high blood pressure in Audrain and Montgomery Counties is $41.1 \%$ and $34.7 \%$, respectively, both of which are higher than the state average of $32.6 \%$

## Cancer

## SSMHealth

Cancer is second only to heart disease as a leading cause of death in Audrain and Montgomery Counties. The top five most common types of cancers in our region include breast, lung, prostate, colon and bladder.

There are a number of economic, environmental and lifestyle factors that contribute to this disparity. The local economy is one that is heavily reliant on agricultural processes that can potentially introduce harmful byproducts into the human system, which can lead to the development of cancer. The data also illustrates that use of tobacco products is significantly greater in our service area than most communities. While SSM Health St. Mary's Hospital - Audrain is not equipped to address all of these influencing factors, we are able to assist our community in providing cancer treatment options and promoting healthy lifestyle practices that are highly conducive to preventing the development of cancer. These include:

- Regular medical exams and screenings. By increasing the chances of discovering cancer early, the success rate of treating and ultimately overcoming a cancer diagnosis also increases
- Creation of a healthy diet and promoting physically active lifestyles
- The provision of smoking cessation programs
- Immunization to protect against viral infections that lead to the development of cancer


## Additional facts and figures

- The age-adjusted death rate due to cancer is 184 and 184.3 deaths per 100,000 persons for Audrain and Montgomery Counties, respectively, compared to rates of 179.5 deaths per 100,000 persons in the state
- The breast cancer incidence rate is 85.6 and 69.5 cases per 100,000 persons for Audrain and Montgomery Counties, respectively, compared to 81.2 cases per 100,000 person in the state
- The lung and bronchus cancer incident rate is 88.2 and 86.7 cases per 100,000 persons for Audrain and Montgomery Counties, respectively, compared to rates of 75 cases per 100,000 persons in the state

- Cancer: Resources include but are not limited to SSM Health St. Mary's Cancer Center, Epic health notifications, the American Cancer Society and SSM Health Medical Group.


## How the data was obtained

SSM Health St. Mary's Hospital - Audrain conducted a comprehensive community health assessment, which included data analysis and soliciting feedback from the community in the form of surveys and focus groups.

Data was collected from various sources, including the US Census, the Centers for Disease Control and Prevention, the Robert Wood Johnson Foundation and the Healthy Communities Institute. Valuable input from community members added depth and quality to the data. Additionally, SSM Health St. Mary's Hospital - Audrain collaborated with community leaders, patients and providers, who contributed much time and effort to this project.

Surveys were administered to SSM Health clinics in Auxvasse, Mexico, Montgomery City, Paris, Perry, Vandalia and Wellsville. Additional surveys were made available in the Montgomery County Health Department. Medical staff and patients responded over a one month period, resulting in completed surveys from 24 providers and 96 patients. Focus groups gathered community feedback from 16 individuals, including representatives from both Audrain and Montgomery County Health Departments.

SSM Health St. Mary's Hospital - Audrain administration reviewed community perception results and health data, prioritizing the top two needs based on the extent of the deficiency and the ability of the hospital to make an impact.

## Primary and chronic disease needs and other health issues of uninsured persons, low-income persons and minority groups

## Appendix

## Information gaps that limit the hospital facility's ability to assess all of the community's health needs

SSM Health St, Mary's Hospital - Audrain observes that, while many health status indicators for its service area might score above average, they may still represent problems that are above the medically preferable prevalence rate (i.e. nonexistent), place a heavy burden on our population, trends might be worsening and/or fall short of acceptable benchmarks. In addition, aggregate health data for the entire population often masks the unfair, heavy burdens on certain groups within the population. SSM Health St. Mary's Hospital - Audrain made a conscious effort to reveal and acknowledge these disparities when possible.

## The health needs of the community

Because SSM Health St. Mary’s Hospital - Audrain has limited resources, not every health indicator which has an identified need for improvement could be addressed. Those community needs identified but not "prioritized" for improvement included the following:

- Mental Health is currently being addressed by SSM Health St. Mary's Hospital - Audrain with the opening of a new gero-psych unit in 2016.
- Access to prenatal care is currently being addressed through the addition of our new OB/GYN who started with SSM Health Medical Group in 2013. He has capacity in his practice and serves this region.
- Obesity and diabetes were not singled out as priorities. Because they are both risk factors for cardiovascular disease, we are addressing obesity and diabetes along with other important risk factors with our identified priority of cardiovascular disease.
- Health literacy is not something we selected as a priority. However, we plan to address patient education and access to services through our two priorities of cardiovascular disease and cancer care.
- Childhood obesity is being addressed by the public school district. They have after school activities for gradeschool age children and coordinate with the YMCA. They also have a one-mile run/walk three times a year with holiday themes.
- Access to dental care: The hospital does not employ the professionals necessary to implement a dental health program.
- Transportation is being addressed by OATS for senior citizens.
- Substance abuse was not prioritized because the hospital does not employ the professionals necessary to implement a substance abuse program.
- Access to care is an ongoing priority at SSM Health St. Mary's Hospital - Audrain. We are constantly assessing areas of physician need within our service areas and developing recruitment plans to increase access to primary care and other specialist providers in the region.
- Care coordination is being handled for patients with cancer via our health and wellness nurses. They coordinate care for patients with recommendations for further testing from screening exams and carry out testing and treatment when cancer is identified. For other patients, our inpatient social services and care coordinators respond to requests for assistance with patients per requests from physician offices. Although this is being handled to some degree, it was not selected as a priority due to others rising to higher priority.

## Heart Disease

Heart disease is the leading cause of death in both Audrain and Montgomery Counties. There are a number of deficiencies within our community that correlate to poor heart health. Some of these lifestyle behaviors that increase the risk of heart disease include:

- Smoking
- Uncontrolled blood pressure
- High cholesterol levels
- Uncontrolled diabetes
- Stress and depression
- Unhealthy food choices
- Lack of exercise

In some cases, minorities and those living under financial distress are often segments of the population who are most affected by factors contributing to heart disease.

SSM Health and SSM Health St. Mary's Hospital - Audrain offer a wide scope of programs with the goal of creating healthy lifestyle behaviors and reducing the risk of heart disease in our communities.


- The percentage of the Medicare population with hyperlipidemia in Audrain and Montgomery Counties is $47.1 \%$ and $44.4 \%$, respectively, both of which are higher than the state rate of 42.5\%
- The percentage of adults with high blood pressure in Audrain and Montgomery Counties is $41.1 \%$ and $34.7 \%$, respectively, both of which are higher than the state average of $32.6 \%$

## Strategic Implementation Plan Heart Disease

## Goals

The goals of SSM Health St. Mary's Hospital - Audrain include:

- Reduce age-adjusted death rate due to heart disease in our region from 231.4 deaths per 100,000 individuals, as reported in 2015, to 225 deaths per 100,000 individuals by 2018 (MICA)
- Decrease percentage of all-cause/all-location congestive heart failure (CHF) 30-day hospital readmission rate at SSM Health St. Mary's Hospital - Audrain from 16\% in 2015 to 15.3\% by 2018 (HIDI)



## Action plan

- Focus on and improve hemoglobin A1C testing within the SSM Health Medical Group in an effort to keep diabetic patients' respective levels in control
- CHF nursing home collaboration: Visits to high-risk patients in nursing homes. Review trends from nursing homes and if outliers exist, work with specific nursing homes to educate about how to make reductions
- High-risk screening: Implement a high-risk screening criteria tool involving mortality and post-acute committees
- Transitional care coordination: Improve post-discharge care and coordination of support for patients
- Collaborate with the county health departments on ways to identify individuals that are high risk
- STEMI Center designation: SSM Health St. Mary's Hospital - Audrain has applied for STEMI Center Designation and is awaiting certification review
- Stroke Center designation: SSM Health St. Mary's Hospital - Audrain will prepare to apply for Stroke Center designation by 2018
- Expand nutrition and dietary counseling services and follow-up
- Increase dietary counseling referrals from SSM Health Medical Group (primary care) to promote healthy diet in adults with a BMI >30
- Provide dietician assistance to the YMCA
- Assessments and screenings outreach: Community and/or worksite risk assessments and screenings, as well as education at least twice a year
- Cardiac disease screening program (calcium scoring) will be offered, beginning in 2016
- Educational awareness: Provide education on prevention and signs and symptoms awareness and implement at least one public awareness campaign such as "Know Your Numbers" or "Health Fest." Additionally, we will continue to host the Heart-to-Heart luncheon in May, which serves more than 200 women with the purpose of educating about heart disease

## Cancer

## SSMHealth

Cancer is second only to heart disease as a leading cause of death in Audrain and Montgomery Counties. The top five most common types of cancers in our region include breast, lung, prostate, colon and bladder.

There are a number of economic, environmental and lifestyle factors that contribute to this disparity. The local economy is one that is heavily reliant on agricultural processes that can potentially introduce harmful byproducts into the human system, which can lead to the development of cancer. The data also illustrates that use of tobacco products is significantly greater in our service area than most communities. While SSM Health St. Mary's Hospital - Audrain is not equipped to address all of these influencing factors, we are able to assist our community in providing cancer treatment options and promoting healthy lifestyle practices that are highly conducive to preventing the development of cancer. These include:

- Regular medical exams and screenings. By increasing the chances of discovering cancer early, the success rate of treating and ultimately overcoming a cancer diagnosis also increases
- Creation of a healthy diet and promoting physically active lifestyles
- The provision of smoking cessation programs
- Immunization to protect against viral infections that lead to the development of cancer


## Additional facts and figures

- The age-adjusted death rate due to cancer is 184 and 184.3 deaths per 100,000 persons for Audrain and Montgomery Counties, respectively, compared to rates of 179.5 deaths per 100,000 persons in the state
- The breast cancer incidence rate is 85.6 and 69.5 cases per 100,000 persons for Audrain and Montgomery Counties, respectively, compared to 81.2 cases per 100,000 person in the state
- The lung and bronchus cancer incident rate is 88.2 and 86.7 cases per 100,000 persons for Audrain and Montgomery Counties, respectively, compared to rates of 75 cases per 100,000 persons in the state

## Strategic Implementation Plan Cancer Care

## Goals

The goals of SSM Health St. Mary's Hospital - Audrain include:

- Reduce the age-adjusted death rate due to cancer in our region from 178.2 deaths per 100,000 individuals, as reported in 2015, to 175 deaths per 100,000 individuals by 2018 (MICA)
- Increase percentage of stage 1 breast cancer initial diagnosis' from 19.7\% (hospital 5-year 2010-2014 baseline average) to 24.7\% by 2018 (Cancer Registrar)
- Increase percentage of stage 1 lung cancer initial diagnosis' from 37.5\% (hospital 5-years 2010-2014 baseline average) to 42.5\% in 2018 (Cancer Registrar)


## Action plan

- Preventive mammograms: SSM Health St. Mary's Hospital - Audrain women's imaging to provide flexible and easy scheduling and convenient hours of operations for screenings at least twice each year. Increase proportion of SSM Health Medical Group female patients 50-74 years of age who have had one or more mammograms performed during the measurement period of 24 months
- Patient/provider reminders: Maximize use of Epic health maintenance notifications to increase preventive screenings and kept appointments. Explore Epic reporting for health maintenance notifications for breast and lung cancer screenings that result in preventive screenings and kept appointments. Evaluate and monitor screening performance and referrals within SSM Health Medical Group and give feedback to clinic providers to boost screening rates. Cancer Screening Services to continue to provide yearly appointments for patients with a reminder letter sent three weeks prior to appointment, as well as a reminder phone call 24-48 hours prior to appointment
- Low-dose CT scanning for lung cancer screening program: Develop low-cost screening program in 2016
- Increase referrals to SSM Health Cancer Center (at the J. B. and Greeta B Building) Screening Program for comprehensive cancer screenings with provider education for SSM Health Medical Group to increase awareness of program, as well as funding for low income women with the Show Me Healthy Woman and Anna Margaret Griffin Grant programs. Continue to educate health care provides on cancer-related topics with the Annual MidMO Regional Cancer Conference to facilitate knowledge, awareness and referrals
- Initiate lung cancer screening program into the existing comprehensive cancer screening program
- Provide convenient times and extended screening hours of service once a month
- Continue community outreach activities to promote awareness at women's conferences/civic organizations and host awareness programs, such as the Victorian Tea for breast cancer awareness
- Education and awareness: Increase offerings on risk factors and important preventative screenings for breast and lung cancer prevention, diagnosis and treatment. Implement cancer screening public service/awareness campaign and media materials that align with cancer prevention months
