Executive Summary - St. Louis City

CHNA Process

Under the Patient Protection and Affordable Care Act (PPACA) enacted in 2010, nonprofit hospitals are required to conduct a Community Health Needs Assessment (CHNA) every 3 years. In the CHNA process, it is also imperative that hospitals pay specific attention to health care concerns that affect vulnerable and marginalized populations. For the 2021 Community Health Needs Assessment, SSM Health followed standard processes, consistent with IRS regulations and standards.

CHNA Process

Over a 12-month period, in collaboration with other local health systems (BJC, Mercy, St. Luke's and Shriner's Hospital for Children) and many other community partners, we conducted a community health needs assessment by gathering health and social determinants of health-related information directly from the communities we serve through a single, regional community survey, a single, regional stakeholder survey and focus groups. Due to the ongoing COVID-19 pandemic, all surveys and focus groups were conducted virtually. 2,915 total CHNA community survey responses, 378 were submitted from St. Louis City zip codes. Additionally, a total of 26 Stakeholder CHNA surveys were submitted by organizations serving St. Louis City. A limited number of focus groups were held to capture additional input from regions with the lowest response rates, primarily in St. Louis City. Additionally, hard copy surveys were provided to a local homeless center (St. Patrick Center) and community center (The Youth and Family Center), both located in underresourced zip codes of St. Louis City.

Quantitative data from a variety of secondary data sources were also assessed, in addition to our own 2019 hospital emergency department utilization data, to further inform our 2022-2024 health priorities. Input received directly from our communities through surveys and focus group conversations have been incorporated to identify concerns about the health of our communities, the types of community-based programs, organizations and services that currently exist to address community needs, as well as to identify gaps and opportunities for the enhancement and advancement of services.

Each source of data: 1) Community Survey, 2) Stakeholder survey, 3) Secondary data and 4) Hospital ED utilization data, played an important role in helping to identify and prioritize health needs based on the level of importance to community members and the hospital's ability to contribute to measurable impact.

CHNA Alignment with our Mission

At SSM Health, we know that healthy communities don't just happen. Improving community health requires long-range, strategic efforts that take into account the entire eco-system of health by also addressing social determinants of health including, social, economic, environmental as well as political factors. Through our subsequent community health improvement plans (CHIPs), we anticipate engaging in a wide-range of activities to address and support meaningful improvements within each identified health priority.

In 2020, we opened the Grand New Saint Louis University Hospital, a state-of-the-art academic medical center that supports our partnership with the Saint Louis University School of Medicine. We are highly equipped in a number of specialties, including cardiology, neurology, transplant, and emergency medicine. Our new ACS-designated Level I Trauma Center is two to three times larger, to meet the growing critical care needs of 75 outlying partner clinics and nearly 50,000 patients annually, within a 250mile radius across Missouri and Illinois. We are a Level 1 Time Critical Diagnosis Stroke and STEMI Center and a Designated Level 4 Epilepsy Center. SSM Health St. Mary's Hospital - St. Louis offers a comprehensive array of acute inpatient services, along with an ambulatory network consisting of urgent care, primary care and specialist providers.

SSM Health St. Mary's Hospital service highlights: The Women and Infant Substance Abuse Help (WISH) Center provides comprehensive, high-risk maternity care for women dependent on opioids and other drugs. It was the first clinic of its kind in Missouri and remains the largest in the state; The Internal Medicine (IM) Clinic ensures a Medical Home Designation for patients - 80% of whom are either uninsured or underinsured; One of the latest service divisions, the Infectious Disease (ID) Clinic, is a recipient of the Ryan White grant, which enables the Clinic to offer a wide array of services to patients living with HIV or AIDS, including those underinsured or uninsured.



Definition of Community

SSM Health Cardinal Glennon Children's Hospital and SSM Health Saint Louis University Hospital are both located in St. Louis City within the 63110-zip code. However, as specialty hospitals, the service area for both hospitals includes the St. Louis metropolitan area and southern Illinois. SSM Health Cardinal Glennon Children's Hospital serves 276 zip codes in its primary service area and 2,214 zip codes in its secondary / outreach service area. SSM Health Saint Louis University serves 89 zip codes in its primary service area and 87 zip codes in its secondary service area. Demographic numbers reflected below represent St. Louis City. In 2018, the population of St. Louis City is estimated at 302,000. SSM Health St. Mary's Hospital is geographically located in Mid- St. Louis County, however, the primary and secondary service areas include zip codes in both St. Louis County and St. Louis City. There are 28 zip codes that are included within or overlap the service area. In 2020, the population of St. Louis county was approximately 980,000.

The CHNA Process: Many Parts Make a Whole



Primary Data-Community CHNA Survey:

A single online community health needs assessment survey was available for community members across multiple service areas of all collaborating hospital systems, inclusive of Missouri and Illinois. The online community survey was available to complete from April 2021 through July 2021. This survey asked about people's personal health, their thoughts about the community's health and provided sections for people to provide on ways to improve both individual and community health. The survey took an average of 10 minutes to complete with a total of 2,915

individuals completing the survey. A total of 378 responses were

received from St. Louis City zip codes, accounting for 13 percent of survey responses

All respondents were asked to provide their primary zip codes, which were tagged according to the SSM and partner hospital CHNA community geographies (e.g., North St. Louis County, South St. Louis County, St. Louis City, St. Charles County). Community members had the option to submit comments at the end of the survey. These comments were analyzed, allowing us to identify the top-ranking suggestions for how to improve both individual and community health, many of which will be integrated within our subsequent Community Health Improvement Plans (CHIPs).

Additionally, community conversations were held virtually, engaging individuals from SSM service areas where response rates were significantly lower in comparison to other service areas, primarily in St. Louis City. Conversations were focused on learning more about residents' concerns, solicit their ideas on and experiences with healthcare and opportunities for improvement. These conversations provided critical insight on community perceptions and idea-generation on how to improve health care access and resources. These conversations also focused on a variety of issues that impact individual and community health and well-being, including service access barriers for underserved populations, as well as environmental barriers to optimal health. Eleven individuals participated in these conversations.



Primary Data-Stakeholder Survey:

Community leaders were also engaged to complete the Stakeholder CHNA survey. Stakeholders included a diverse group of community professionals from organizations across St. Louis City and surrounding service areas, providing a vast array of critical services including health access, social needs, education and emergency services. Upon completion, surveys were analyzed through the survey platform in order to identify common themes. A total of 26 stakeholder surveys were submitted from organizations representing St. Louis City.

Primary Data-Hospital Emergency Department Utilization Data:

According to a 2021 report by the Department of Health and Human Services on emergency department utilization trends, community members seek care in the hospital emergency departments for a wide variety of reasons, including problems with access to services in other settings as well as the challenge of determining the urgency of symptoms such as chest or abdomen pain without further diagnostics. It is important to assess the trends in usage and top reasons for which individuals are seeking care in the ED, as they provide critical insights on the health of the communities the hospital is serving, and thus, an extremely valuable contribution to the CHNA process.

Of just over 200 emergency department health conditions assessed for SLUH, CG and SM for 2019, several conditions in the top 25 most common conditions were closely associated with 2022-24 priorities of *Behavioral Health*, Obesity/*Chronic Conditions, Violence/Injuries and High-risk pregnancy/Women's Health*. These top conditions include substance use disorders, psychosis, poisonings/toxic exposure, blunt injuries, Diabetes, Heart failure and high-ris pregnancy conditions.

Secondary Data:

Secondary data was collected from multiple sources including The County Health Rankings, ExploreMoHealth, and Missouri Public Health Information Management System. Analysis of these data sources revealed not only the most burdensome health issues for the South St. Louis County region, but also health disparities and key issues impacting social determinants of health. Data assessed included demographic information, chronic disease and morbidity/mortality information, health status indicators, health behaviors and general environment information. This data is compared to state and national benchmarks.


Primary and secondary data were weighted in order to determine highest priority community health needs, based on importance to community members and the hospital's ability to make meaningful impact over the next several years.

This assessment and prioritized health needs were then presented to SSM Health Saint Louis University Hospital, SSM Health Cardinal Glennon Children's Hospital and SSM Health St. Mary's Hospital, SSM Health St. Louis Regional and System, and SSM St. Louis Board of Directors for approval.

Health Equity and Social Determinants of Health

Health Equity

Equity is defined as "the absence of avoidable or remediable differences among groups of people, whether those groups are defined socially, economically, demographically, or geographically" (World Health Organizatio 2016). Health is a fundamental human right, therefore, to address health inequities interventions need to be effective and sustainable, focused on empowering those experiencing inequities (WHO, 2016).



A characteristic common to groups that experience health inequities—such as low-income or marginalized persons, racial and ethnic minorities, and women—is lack of political, social or economic power. Research also indicates a strong relationship between self-reported racism and discrimination with negative mental health outcomes and negative health-related behaviors. These outcomes are seen even after controlling for the differences among groups such as socio-economic status and access to adequate health care. The effects on health can include the following:

- Higher blood pressure Lower immune function
- Higher rates of nicotine and alcohol use and poor nutritional intake
- Lower rates of exercise and social support Higher rates of infant mortality

Social Determinants of Health

The social determinants of health (SDoH) are the non-medical factors that influence health outcomes. They are the conditions in which people are born, grow, work, live, age and the wider set of forces and systems shaping the conditions of daily life. Examples of these factors include safe and affordable housing, access to quality education, public safety, availability of healthy foods, accessible health care services, and positive social support systems. Research shows that the social determinants can be more important than health care or lifestyle choices in influencing health. For example, numerous studies suggest that social determinants account for between 30-55% of health outcomes. In addition, estimates show that the contributions of sectors outside of healthcare exceed the contributions from the healthcare sector when it comes to community health. By applying what we know about SDoH, we can not only improve individual and community health, but also advance health equity. Our Community Health Needs Assessment survey was rooted in questions focused the social determinants of health.



Please Rate Your Level of Concern About Each of These Health Needs on a Scale of 1 (Little concern) to 5 (Significant Concern)








Barriers to Health Care

The National Academies of Sciences, Engineering, and Medicine defines access to health care as the "timely use of personal health services to achieve the best possible health outcomes." It is important to address barriers that prevent or limit access to needed health care services, as this lack of access may increase the risk of poor health outcomes and health disparities. Top barriers to healthcare noted by St. Louis City survey respondents include costs/co-pays, scheduling problems, difficulty finding doctors and fear.



St. Louis City Responds-Solutions

The online CHNA survey consisted of 39 questions and took respondents an average of 10 minutes to complete. The final two questions, 38 & 39, offered respondents an opportunity to share their thoughts about best solutions for addressing barriers to optimal health. The word clouds below illustrate the solutions referenced most frequently by St. Louis City respondents.

"You know, for this area, there's no fresh, like fresh time, there's no fresh food, I mean, no fresh vegetables, no fresh meat...And there's no variety. It's like, I have the commodity so I'm holding, I'm the ruler here. But for a community of this size, there should be more access to somebody just being able to go get an apple from the store or go get peaches from the store." G3, 2

"Like, you're not important to them. It's just that they know that you're here, they know that this is all that you have.... we're like, held hostage to what they give us, or what's available here {food access}." G3, 1

That definitely could be a health care initiative itself, to create some type of, like, area for people to exercise or to just get some of that healthy time in to move around with their families in a clean spot in their neighborhood that they may not have from their own home and things like that. G1, 3



Discharges with Medicaid as Primary Payer per 1,000 Total Population by ZIP Code, ZHR 2020 $\,$


















